



## Introduction

#### **About us**

The Occupational Therapy Council of Australia Ltd (OTC) is a company limited by guarantee and a registered charity with the Australian Charities and Not-for-Profit Commission. Occupational therapy was included as a registered profession in the National Registration and Accreditation Scheme (NRAS) on 1 July 2012. The OTC was appointed by the Occupational Therapy Board of Australia as the independent organisation to ensure that standards of education, training and assessment of occupational therapists are maintained and developed so the Australian public is assured of safe and proper practice.

The OTC has also been appointed by the Department of Home Affairs as the relevant assessing authority for the purposes of skilled migration in the category of ANZSCO 252411 - Occupational Therapist.

#### **Our vision**

Contributing to a safe, flexible, innovative and culturally responsive occupational therapy workforce.

#### **Our core functions**

- to develop and apply program accreditation standards in occupational therapy
- to accredit and monitor occupational therapy programs of study and education providers
- through supervised practice, assess internationally qualified occupational therapists who are seeking registration in Australia
- assess occupational therapists for skilled migration purposes.

#### A message from our Chair



I am pleased to present the OTC Board report of the Occupational Therapy Council of Australia Ltd (OTC) for the 12 months ended 30 June 2025.

It has been an eventful year for the OTC and one that has seen significant change. At the end of 2024 we farewelled our long-standing CEO, Mr Kim Bradbury. Kim has been the CEO of the OTC since it commenced operation and was the inaugural CEO of the Council of Occupational Therapists Registration Boards (Australia and New Zealand) Inc when it was established in 1996 and changed its name to the Occupational Therapy Council (Australia and New Zealand) Inc in 2010. Following the inclusion of the occupational therapy profession in the National Registration and Accreditation Scheme, Kim was fundamental in securing the appointment of OTC as the assessment and accreditation authority under the Health Practitioner Regulation National Law and ultimately the organisation's transition to a public company limited by guarantee in 2012.

Kim has been an invaluable leader, guiding us through numerous challenges and achievements. His commitment to the OTC's vision and values has helped us grow and evolve into the organisation we are today. We are deeply grateful for his contributions and leadership and wish him the best in his retirement.

The OTC Board was pleased to appoint Ms Anne Szadura, OTC's Accreditation Manager as Acting CEO from 1 January 2025 and, following a successful interim period, to confirm her ongoing appointment to the role from 14 April 2025. Anne brings a wealth of experience in accreditation, policy, and leadership within the tertiary education sector. Her experience, inclusive leadership style, and deep commitment to cultural safety strongly align with the OTC's values and strategic directions for the future.

A significant and important focus over the reporting period has been on embedding Aboriginal and Torres Strait Islander voices and leadership across our operations and governance. To support this work, we engaged Yamagigu Consulting Pty Ltd, a First Nations consultancy, to review and further develop our governance structures in ways that promote cultural safety and build organisational cultural capability, including in relation to Board appointments. Yamagigu's recommendations are being embedded across our governance and operations, helping to support the self-determination of Aboriginal and Torres Strait Islander peoples and bringing a culturally informed perspective to enable meaningful change.

Building on this, we commenced work with Directors Australia to strengthen governance practices and introduce external, independent advice into our processes. Directors Australia has also supported the recruitment of new Board members – including Aboriginal and Torres Strait Islander representatives – with appointments to be finalised shortly in the new financial year, followed by a tailored induction and buddying process for new directors.

The health accreditation landscape under the National Registration and Accreditation Scheme (NRAS) continues to evolve rapidly, shaped by a number of significant national reviews during this period. These include:

- the Dawson Review of complexity in the NRAS, which includes recommendations related to accreditation functions and strengthened accountability mechanisms
- the National Health Practitioner Ombudsman (NHPO) report and recommendations, providing further insight into regulatory practices and stakeholder concerns, and
- the Kruk Independent Review of health practitioner regulatory settings, which sets out wide-ranging recommendations to simplify and expedite the registration process for internationally qualified health practitioners.

As part of the recommendations of the Kruk review, the OTC has been working closely with the Occupational Therapy Board of Australia (OTBA) and Ahpra to support the development of three new streamlined pathways to general registration for internationally qualified occupational therapists. These new pathways are expected to come into effect from late 2025.

Under the revised model, candidates will apply directly to Ahpra for qualification assessment. Where a candidate holds a qualification that is deemed substantially equivalent to, or based on similar competencies as an approved qualification, they will be eligible to apply for general registration without the requirement for supervised practice. Candidates holding a qualification the Board considers relevant to occupational therapy, but not substantially equivalent, will be required to undertake a practical assessment of competence before applying for registration. The OTC will continue to deliver and oversee this important assessment function, contributing to the integrity and robustness of the registration process.

The OTC will also continue to assess for skilled migration purposes as the assessing authority for occupational therapy appointed by the Department of Home Affairs.

Thank you to all the people who have contributed to OTC operations over the last year – Board members, Committee members, staff and assessors. I deeply appreciate your dedication, professionalism and expertise, which enable the OTC to continue to meet its functions under the National Law.

#### A message from our CEO



I am honoured to present the 2024/2025 annual report – my first as the CEO of the Occupational Therapy Council of Australia Ltd (OTC).

I would like to begin by acknowledging my predecessor, Kimberley (Kim) Bradbury, who, after 40 years of dedicated service to the OTC and the occupational therapy profession retired at the end of 2024. Under his leadership, the OTC has built strong foundations, including a dedicated and capable Secretariat and a sound financial position.

I feel privileged to now lead such a dedicated team in continuing this important work. I also feel fortunate to be working alongside an expert and supportive Board, whose knowledge and guidance have been invaluable during this period of transition. Our focus remains firmly on ensuring Australia has a high-quality occupational therapy workforce – one that is not only clinically capable, but also culturally safe, responsive, and well positioned to meet the diverse health needs of the Australian community.

This year marked a pivotal period of growth and transition for the OTC, which I envision will continue into the next 12 months. In the latter part of 2024, we received confirmation of our renewed assignment as the accreditation authority for occupational therapy for the next five years with the Occupational Therapy Board of Australia (OTBA). This reaffirmation of our role brings a strong foundation from which to continue evolving our processes and strategic direction in a dynamic and changing environment.

Through the ongoing generosity of Indigenous Allied Health Australia (IAHA), we have continued to implement our Cultural Responsiveness Plan (CRP). The recommendations from the *Aboriginal and Torres Strait Islander Health Curriculum Implementation Project*, completed at the end of 2023, have been integrated into the CRP to support a coordinated and consolidated approach to their implementation.

In addition to these important cultural capability initiatives, we have reviewed and strengthened our governance and risk frameworks, including the development of a formal Risk Management Policy, an updated Risk Management Plan, and a new Risk Appetite Statement. These tools will better support our strategic decision-making and risk oversight.

We have also worked collaboratively with the Occupational Therapy Board of Australia (OTBA) and Ahpra to respond to the recommendations of the Kruk Review into health practitioner regulatory settings, contributing to broader sector-wide reform, including streamlined assessment processes for internationally qualified health practitioners.

A personal highlight was being able to bring together our accreditation assessors in person for the first time since the COVID-19 pandemic, with a two-day workshop held in Melbourne in February 2025. The energy, insight, and collaboration during this event was a powerful reminder of the calibre and commitment of the professionals who support our work.

I would also like to express my sincere thanks to our committee members, program assessors, and Secretariat staff for their ongoing dedication, professionalism, and generosity of time and expertise. Their collective efforts are central to the success of our accreditation work and the broader goals of the organisation. I am continually inspired by their commitment to upholding high standards and supporting culturally safe and responsive practice across the profession.

Finally, I would like to recognise and thank our external stakeholders and partners – the OTBA, Occupational Therapy Australia, IAHA, ABSTARR Consulting Pty Ltd, the National Aboriginal and Torres Strait Islander Occupational Therapy Network (NATSIOTN), education providers, and internationally qualified practitioners – for their ongoing collegiality, engagement, and shared commitment to strengthening occupational therapy in Australia.

I look ahead with optimism to the challenges and opportunities ahead. As we continue to work towards our vision of an innovative, safe and culturally responsive occupational therapy workforce I look forward to keeping you updated on our work and achievements in the year to come.

### Governance

The OTC is committed to maintaining high standards of governance to ensure accountability, transparency, and effective oversight of its strategic and regulatory functions. The Council works in accordance with its strategic and regulatory responsibilities and upholds principles of good governance across all areas of its work.

#### **OTC Board of Directors**

The Council is governed by a Board currently comprising six members with diverse expertise in occupational therapy education, clinical practice, regulation, law, and not-for-profit governance. Board members are appointed in line with the OTC's Constitution, ensuring a balanced representation of professional and community perspectives. There are up to three members who are not occupational therapists to ensure the relevant is of skills and capabilities. The powers and responsibilities of the Directors are set out in the OTC Constitution, the Corporations Act, and the Australian Charities and Not-for-Profits Commission Act.

#### Overseas Qualification Assessment Committee (OQAC)

OQAC assesses the qualifications of internationally trained occupational therapist for registration and migration purposes. This includes evaluating eligibility for supervised practice, monitoring that practice, and conducting migration assessments for both internationally qualified and Australian-qualified occupational therapists on behalf of the Department of Home Affairs.



#### **Occupational therapy programs**

This reporting period has seen a continued increase in the number of new occupational therapy programs being developed and introduced, with five new programs accredited in 2024-2025. This trend looks likely to continue into the foreseeable future as we have also received several enquiries, and notices of intent, for further new programs. We also reaccredited seven programs across three education providers. The resulting increase in accreditation activity has required OTC staff, assessors and the Program Accreditation Committee (PAC) to manage a significant workload, and we sincerely thank them for their professionalism, adaptability, and commitment throughout the year.

#### **New PAC members**

During this period the Board appointed two new members to join the PAC and the OTC is very pleased to welcome Ali Gebhardt, a proud Wiradjuri woman and associate lecturer in occupational therapy at Western Sydney University, and Jan Connolly, a community representative with significant experience in program accreditation and the higher education sector. We look forward to their contributions to PAC into the future.

#### **Assessors**

In view of the significant number of site visits scheduled to occur in future years, two additional program assessors have been appointed – Ali Gebhardt and David Parsons. David is Associate Professor in occupational therapy at the University of Notre Dame Australia at the Fremantle campus.

In February 2025, we were delighted to host twenty assessors at a workshop in Melbourne – the first face-to-face event we have held since the COVID-19 pandemic restricted such activities to being held online. Along with the opportunity to come together as a community of practice, focus areas for discussion over the two days included:

- Al in education, its application in health services and the challenges for both education providers, and regulators, to ensure assessment of students remains valid and authentic
- an interactive discussion with the OTBA on the professional competency standards and potential changes arising from their review; and abbreviated reports
- consideration of the recommendations from the Aboriginal and Torres Strait Islander Health
- Curriculum Implementation Project Occupational Therapy Program Accreditation (2023) and the importance of everyone's ongoing cultural safety training to ensure culturally informed accreditation practices.

#### **Culturally safe accreditation**

Cultural safety remains an important priority in our accreditation functions. Over half the OTC's accreditation staff, assessors, and members of PAC completed the Aboriginal and Torres Strait Islander Cultural Safety in Health Program Accreditation training delivered by ABSTARR Consulting Pty Ltd in 2024–2025. The remaining participants are scheduled to complete the program by early 2026.

#### **Engaging with education providers**


The OTC works closely and collegially with our education providers to support the understanding of accreditation standards and OTC processes. Our engagement includes attendance at the annual ANZCOTE/ANZOTPEA meeting, which was held on 13 August 2024, and individual guidance for providers seeking both first-time accreditation of new programs and reaccreditation of existing programs. We have also continued sending out *Accreditation matters*, our biannual newsletter, which includes information about key things the OTC is working on, areas of shared interest, and examples of innovation being undertaken across the sector. This newsletter is distributed to a wide range of stakeholders, including education providers and we continue to receive positive feedback about it.

From July 2024 we reintroduced post site visit surveys as part of our continuous quality improvement processes. Following all accreditation site visits, we send out two online surveys – one to education providers and the other to assessors involved in the site visit. We encourage education providers to circulate the survey to staff, students and other stakeholders who participate in the accreditation review process. The feedback received assists the OTC in identifying any concerns and refining accreditation processes.

## International assessment

The volume of applications from internationally qualified occupational therapists seeking registration in Australia has remained steady with consistently high numbers of applicants from the United Kingdom, the Philippines, South Africa and India.

#### **New committee members**

During this period the Board appointed two new members to join the Overseas Qualifications Assessment Committee (OQAC). We are very pleased to welcome Deborah Gellie and Catherine Greenway to the committee. Both are OQAC assessors and practising occupational therapists, and we look forward to their valuable contributions to the work of the Committee into the future.

#### **Assessors**

There are now eleven assessors for the 'Stage 2' process, with the appointment of three new assessors during the reporting period. To support a smooth transition, new assessors are provided with a buddy arrangement, enabling them to become familiar with the assessment process under the mentorship of a more experienced assessor.

The assessors are Susan Gilbert-Hunt, Jan Erven, Deborah Gellie, Frank Gomes, Irena Gordon, Catherine Greenway, Elaine Lee, Ngoni Mandiringana, Tristan Chan, Michelle Singh and Faye Buckton. We thank these assessors for their commitment and dedication in evaluating internationally qualified practitioners, ensuring they possess the competencies and readiness required to practise safely and effectively within the Australian context.

#### **Digitisation of the assessment process**

In 2025, we commenced updates to the international candidates' database to enable greater digitisation and efficiency in the assessment process. The OTC Secretariat is working closely with our external database service provider to implement these enhancements, which are expected to be completed later in the year.

#### **New assessment pathways**

The OTC Board accepted an invitation from the Occupational Therapy Board of Australia (OTBA) to develop a new streamlined assessment pathway under the National Law to enable eligible internationally qualified practitioners whose qualifications are considered by the National Board to be substantially equivalent to, or based on similar competencies as an approved Australian qualification, to apply for general registration without undertaking the Stage 2 supervised practice assessment.

This development responds to the recommendations of the Kruk Review, completed in December 2023, which addressed healthcare workforce shortage issues across Australia.

The OTBA accepted the OTC's Phase 1 proposal to conduct an environmental scan and design for the new pathway. Phase 1 commenced on 1 July 2024 and was completed on 11 October 2024. While the subsequent development of the Section (53(b) pathway was awarded to Ahpra, the OTC continues to contribute expertise to ensure the approach remains suitable for internationally qualified practitioners.

The new pathways are expected to launch in late October/early November 2025. Once implemented, applicants will apply directly to Ahpra for a qualification assessment. This assessment will determine whether the applicant's qualification is substantially equivalent to or based on similar competencies as an Australian occupational therapy qualification. Applicants who meet this standard will be eligible to apply for general registration.

If an applicant's qualifications are not deemed substantially equivalent but are still considered relevant to occupational therapy, they will be required to apply for limited registration and will complete a practical assessment of competence (similar to the current 'Stage 2'), which will continue to be facilitated by the OTC. Successful completion of this assessment will be necessary to become eligible for general registration as an occupational therapist.

These upcoming changes represent a significant shift in current processes. The OTC Board, OQAC and Secretariat are actively reviewing existing policies and procedures to identify and implement necessary updates.

#### **OTC representation on Expert Advisory Group**

Ms Susan Gilbert-Hunt, OTC Director and Chair of OQAC has participated in Ahpra's Expert Advisory Group Project: Streamlined Pathways (Non-Medical), which includes five professions—occupational therapy, dentistry, medical radiation, podiatry, and psychology. Ms Gilbert Hunt remains a strong advocate for ensuring cultural safety continues to be a central focus in the assessment of internationally qualified practitioners.

# Strengthening our cultural responsiveness

frameworks.

The OTC is committed to fostering a culturally responsive organisation that recognises, respects, and values the diverse backgrounds, experiences, and perspectives of the communities we serve. Cultural responsiveness is embedded in our policies, Code of conduct, operations, and decision-making

We acknowledge the critical importance of cultural safety, particularly for Aboriginal and Torres Strait Islander peoples, and are committed to promoting equitable and inclusive outcomes across the health and regulatory sectors. We recognise and respect Aboriginal and Torres Strait Islander ways of knowing, being and doing as being equal to Western frameworks.

Cultural protocols are observed at all meetings, and the Program Accreditation Committee has introduced Indigenous ways of knowing, being and doing into its practices, including dedicated time for yarning at the beginning and end of meetings. We have also embraced the Aboriginal and Torres Strait Islander approach to introductions, where individuals share who they are rather than focusing solely on their organisational roles. This approach has proven to be both meaningful and impactful and is increasingly becoming standard practice across our organisation.

In alignment with our commitment to fostering culturally safe environments, we continue to collaborate with Indigenous Allied Health Australia (IAHA) to ensure ongoing reciprocity and genuine engagement with Aboriginal and Torres Strait Islander peoples. This includes incorporating IAHA's guidance into our processes, and seeking feedback and evaluation of our actions related to cultural safety, project implementation, and other relevant activities. We met with IAHA on 1 November 2024, with insights from the workshop directly informing updates to our Cultural Responsiveness Plan.

Also in November 2024, Associate Professor Margaret Cook, Chair OTC, Professor Geneviève Pépin, Director and Ms Anne Szadura, CEO attended the IAHA National Conference, where the Chair was honoured to present the Excellence in Cultural Responsiveness Award to Ms Belle Selkirk. As part of our ongoing support, the OTC continues to sponsor an Aboriginal and/or Torres Strait Islander occupational therapy student or practitioner to attend the conference. The 2024 scholarship recipient was Ms Tahnee Elliot, an occupational therapist based in regional South Australia.

Additionally, Ms Szadura attended the pre-conference Allyship Workshop and later presented the principles of allyship to the OTC Board and staff. These principles have been embedded into our Cultural Responsiveness Plan to further strengthen our organisation's allyship practices.

All staff, directors and committee members complete Levels 1 to 3 of the Indigenous Allied Health Australia (IAHA) cultural responsiveness training. In addition, during 2024 to 2025 over half the OTC's program assessors, Manager, Accreditation, Professional Advisor, Program Accreditation, and three members of the Program Accreditation Committee undertook the Aboriginal and Torres Strait Islander Cultural Safety in Health Program Accreditation training developed by ABSTARR Consulting Pty Ltd, which focuses on the principles and application of cultural safety in accreditation processes. It is planned for all remaining accreditation contributors to finish the training over the next 12-18 months

In program accreditation, there continues to be engagement with Aboriginal and Torres Strait Islander stakeholders at every program accreditation on whether and how appropriately education providers and programs are meeting the OTC Accreditation Standards especially pertaining to Aboriginal and Torres Strait Islander input into program delivery and design of the program, and integration of cultural capability in student learning outcomes.

All internationally qualified occupational therapists (IQOTs) seeking registration to practise in Australia are required to successfully complete the cultural responsiveness and awareness training program

delivered by IAHA, on behalf of the OTC. As part of Level Three of this program, IQOTs must develop and submit three personal SMART goals to support their ongoing development in cultural responsiveness. This component is assessed directly by IAHA. In addition to the IAHA training, IQOTs are required to complete a period of supervised practice and demonstrate their ability to maintain and apply cultural responsiveness in clinical settings. This is documented in the Supervised Practice Implementation Plan (SPIP), which forms a key component of OTC's assessment process.

OTC representatives – Assoc Prof Margaret Cook, Prof Genevieve Pepin and Ms Anne Szadura - attended the IAHA Conference in Adelaide in November 2024. The OTC sponsored the Excellence Cultural Responsiveness Award and a student scholarship.

The recipients of these were Ms Belle Selkirk and Ms Tahnee Elliott respectively.
